CHAIR'S REPORT

I am pleased to present this fifth chairman's Report on behalf of the Fraser Park Sportsville Board for what has been another very challenging year.

Throughout the year Covid -19 has played havoc with our ability to open and maintain our facility as we would have liked and it has been of total credit to the tenancy and passion of our team lead by our manager Liz Le Prou that we have managed to stay open at times when the facility has been under such considerable pressure both from a health perspective as well as financial perspective. This would also not have been possible without the support, understanding and co-operation of our member organisations. You have all been outstanding!

On 17th August 2021 New Zealand went into full lockdown again under 'red' in the traffic light system and stayed that way until the country moved back to 'Orange' on 8th September 2021. During this period alone Sportsville recorded \$25,564 worth of cancelled bookings and throughout the following 6 months we saw a consistent theme of \$1500 to \$2000 worth of bookings cancelled. Our door count for visitors to Ricoh fell from 30,374 visitors during July to 10,805 in August. Since returning to 'Orange' we have seen a slow return to pre-Covid visitor numbers. All this has had a significant impact on our viability so while we have recorded a negative \$15,580 result we should also note that depreciation of close to \$47,000 needs to be considered. Given what we have navigated through, the board are satisfied with this result and acknowledge the MSD Wage subsidy contribution of \$28,800 and the additional Resurgence Payment of \$6,087 in helping to achieve this.

Thank you to everyone who has played their part in supporting this fantastic facility.

At last year's AGM the board received critique regarding the financial reports of Fraser Park Sportsville Limited and this year we have looked to acknowledge and rectify this. We would however ask members to appreciate that we can only disclose information regarding the relationship between Fraser Park Sportsville Limited and Fraser Park Sportsville Incorporated and not the contracted catering services as provided by Fraser Park Hospitality. Members will recall that we parted company with Hunts Restaurant at the beginning of the financial year with new caterier Fraser Park Hospitality taking over, just before lockdown. We have collectively worked hard to support our new catering service, which has continued to meet its financial obligations to Limited despite being severely impacted by Covid-19. Given the financial fragility of FP Limited this board have chosen to build reserves to protect itself from further financial stress, should another lockdown occur, or we have another change of caterer. Any return from our caterier to FP Incorporated has therefore been centered on lease payments while FP Limited focusses on building reserves and repaying its loan to FP Incorporated which still stands at \$58,937.

Given the challenging operational environment the board have made slower than expected progress in delivering against the strategic plan outcomes that we set for ourselves last year. One area that the board has been acutely aware of is its connection and understanding of the local community that we serve. The board are currently working to address this skill set and experience at the board table to better understand the community. We have also introduced a regular section in our board agenda to meet with individual Founding Member

Clubs to better understand their challenges and opportunities and how the board can best support the needs and aspirations of our member organisations.

In building a more strategic relationship with our major stakeholder Hutt City Council, we are also looking to take a more strategic approach to the development of Fraser Park as a whole. Ricoh Sports Centre sits in the middle of incredible open and sporting space and the inter-connection between each part of Fraser Park must be considered as a whole, as part of a master plan and not just as individual facilities. This work with council has just begun so that we can collectively meet to needs and aspirations of our member organisations and the local community into the future.

In summary it has been a year of challenge and slow progress given the impacts of Covid-19 on the health and wellbeing of our staff and our organisation, but we remain incredibly excited and upbeat regarding the potential of the amazing facility as we move forward together. I finish by paying tribute to our highly skilled and highly committed board who have given hundreds of hours of their personal time to help navigate the organization through such rough seas. A special acknowledgement of board member Hannah Keat who stepped down in July after several years of incredible service. Hannah brought unique business and project management skills to the board, which will be hard to replace.

Thank you to everyone who has played their part in supporting this fantastic facility.







Operations

Another very challenging year for the FPS Team and facility. Covid 19 again has had a big impact on our operations but in saying that there were many positives - exciting tournaments, hireage hours are up and door count has increased. Whilst the financial accounts are showing a loss this year of \$15k we have introduced \$47k of depreciation which was not reflected in last years financials so overall I think we have done very well under trying environment.

Our extended Reception hours are proving to be invaluable with a much better service delivery to our member clubs and hirers.

We have had staff changes this year which in itself is always challenging when knowledge walks out the door. Tash Szalkowski went on Maternity Leave (returning May 2023) and Malaya Gibbs stepped into this role and did a really good job. We bought on board a new Kaitiaki, Ben Gillies to replace Dale. Unfortunately Troy McGrath our cleaner could not return to work following his sickness and we have contracted out our cleaning services. We have also contracted out to Nuku Ora our financial services and we have Deane Carson as Finance Contractor who is in the Office ten hours per week.

We have a small dedicated team who operate this magnificent facility and we have become masters of multi tasking.

The facility has seen a good increase in community groups hiring spaces this year for meetings, workshops, conferences and private functions. We are continuing to build our relationships within the community and our best form of advertising is word of mouth. We have received a lot of very positive

feedback on the facility and the service that is being provided.

We are very much looking forward to growing the facility next year – there are many opportunities in the pipeline for new and exciting events – both locally, regionally and nationally. The versatility of the Ricoh Sports Centre is becoming well known and is reflected in continuous enquiries for hosting tournaments and events.

I would like to thank Fraser Park Hospitality Limited who came on board in November and took over the Café, Restaurant, Bar and catering services. They operated under very trying conditions for their first six months with covid, staff shortages and it's a credit to them for hanging in there. We are looking forward to seeing what they can achieve in the next year.

I would like to thank the Member Clubs for all their support and co-operation over the year and to the Wellington Phoenix Academy based here for all their support of our team.

I would also like to thank the Hutt City Council for their continued support and encouragement and look forward to working closely together next year to jointly showcase this wonderful facility.

I cannot say or thank enough the Fraser Park Sportsville Board led by Chair Colin Stone. The hours of work and dedication they contribute as volunteers is amazing. The encouragement and support that I receive from them is invaluable.

Notes to the Financial Statements

Fraser Park Sportsville Incorporated For the year ended 30 June 2022

1. Reporting Entity

Fraser Park Sportsville Incorporated ("The Society") is a Company incorporated under the Incorporated Societies Act 1908.

2. Statement of Accounting Policies

Basis of Preparation

These financial statements have been prepared to comply with PBE-SFR-A(NFP) Standards.

The financial statements have been prepared for Board reporting and taxation purposes.

Historical Cost

These financial statements have been prepared on a historical cost basis. The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$, except when otherwise indicated.

Changes in Accounting Policies

There have been no changes in Accounting Policies. All policies have been applied on bases consistent with those used in previous years.

Income Tax

The Incorporated Society qualifies for an income tax exemption on income.

Fixed Assets and Depreciation

All fixed assets are recorded at cost less accumulated depreciation. Depreciation of the assets has been calculated at the maximum rates permitted by the Income Tax Act 2007.

Notes to the Financial Statements

Fraser Park Sportsville Incorporated For the year ended 30 June 2022

Accounts Receivable

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.

Revenue Recognition

Income is recognised when invoiced, or receipted, except where income is received in advance. Income in Advance is stated as a current liability where the funds have not yet been expended, according to the authorised purpose, and those funds would be required to be repaid to the funder.

Leases

Finance Leases

Assets purchased or used pursuant to finance leases are included as fixed assets in the Statement of Financial Position and depreciated at maximum rates allowed by the Income Tax Act 2007. Finance leases, which effectively transfer to the lessee substantially all the risks and benefits incidental to ownership of the property, are capitalised at the present value of the minimum lease payments. A corresponding liability is also disclosed with lease payments being apportioned between the liability and interest payments. Operating Leases

Operating leases are those which all the risks and benefits are substantially retained by the lessor. Lease payments are expensed in the periods the amounts are payable.

Goods and Services Tax

All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Wellington Niue Rugby League became an Incorporated Society in May 2021. It all started when I had an initiative to start up Wellington Niue Rugby league for our children. After previously participating at the Pacific Nations rugby league tournament in 2020 as a coach for another nation, it came to me that Niue had no Juniors participating at the tournament. I quickly concluded that I would reach out to members of our Niuean community and start a Niuean Juniors club up so we could give our Niuean children the same opportunity as our other pacific nations and enter future tournaments. My wife Gene Solia-Gibb and I had previously for the 6 years prior to 2021/22, we had run the Wellington Niue Rugby league Senior men's team. This was a very successful journey. But we were quick to realize there needed to be a foundation, and our foundation is our future, our young Niuean's needed an opportunity to pave the way. We started a committee and became an Incorporated Society in May 2021.

It was a very successful year 2021 for WNRL. We held multiple muster days to engage our community. We took online registrations and by the time we came to play, we had approximately 60 Children register with us who identified themselves as Niuean. The ages ranged from 4 years old to 17 years old, both Male and Female. This was humbling to have this many Niuean kids want to be a part of our Rugby league

We managed to secure a Home for Wellington Niue Rugby league. We now operate out of Ricoh Sports Centre in Lower Hutt. The Venue is home to a vast majority of local elite sports clubs. WNRL is the first Pasifika sports group to be an official member at Ricoh Sports Centre.

We now have Training and playing facilities available to us to hire, as well as storage facilities to secure our training gear and playing strips. We also have function rooms and meeting rooms available to us to hire out. WNRL are so grateful and happy to work with the staff at Ricoh Sports center as well as working alongside other sporting codes. We learn a lot from the other clubs based at Ricoh and have a lot of interest in how they operate. Building relationships is a key factor for our success and we look forward to building further relationships within Ricoh Sports Centre.

WNRL had fixtures over 3 consecutive weeks last year. We were able to host Wellington Tonga Rugby league last year at Ricoh, this was an amazing and successful event for our community. Our players and community experienced a historical moment. Bringing out pure passion and how proud our Niuean Community were at these fixtures. There were Flags flying high, singing, laughter and most of all there was togetherness. Not only within our own Niuean Community, but also with our wider Pasifika community. We came together and celebrated and expressed who we are and our identities, through the game of rugby league.

To conclude our first ever season, we finished off with

team photos and a welldeserved prizegiving for our players to share with their families. Here we acknowledged our volunteer coaches and managers and acknowledged our future Niuean Superstars. Moving in to 2022 we can be proud to say not only did we make history, but we achieved something so great. We gave opportunity to our Niuean Children to be a part of something special. Something that is theirs and that they belong to. We gave them opportunity, not only in the sport of rugby league, but also in their culture. We taught them How to be a part of a team, RESPECT, Prayer, Songs, how to introduce yourself in the Niuean Language, Takalo and most of all what they think it means to them to be Niuean. When we are out in public, we still see our Brand being worn proudly by these children, and when I see that it makes me feel so happy that what we done for our future generations, is something we can all be proud to have been a part of.

Earlier this year 2022, we were able to host another two historical events, the first being an achievement that no other pacific nation Rugby league group has done, we are now Affiliated to Wellington Rugby league. We are the first Pacific Rugby league group to do this. We learnt a lot from 2021 and we aim to better ourselves for the coming years. We held an official letter signing between WRL and WNRL with the WRL CEO, Board members from both sides present, alongside dignitaries, high titled people from our community and NRLNZ representatives who flew down from Auckland for the occasion. This was a great occasion, and we are grateful for the venue Ricoh Sports Centre to host such a significant event.

We also were lucky enough to hold our Lower North Island rep trials for NRLNZ at Ricoh earlier this year as well as our junior Muster Day. NRLNZ (Niue Rugby League New Zealand) flew into Wellington for the day and the feedback on the facilities was great, they were very impressed with the facilities and what it has to offer. Income Tax

The income tax expense in profit or loss represents the estimated current obligation payable to Inland Revenue in respect of each reporting period after adjusting for any variances between estimated and actual income tax payable in the prior reporting period.
